Applications are mailed to the NC JCI Senate treasurer, and due by December 1

1. All applications must be signed by the local Chapter President. (If the local Jaycee organization has folded then the application must be approved by the President of the North Carolina Jaycees and the President of the United States Junior Chamber. If the current local Chapter President is the nominee, the application must be signed by two local chapter officers.)
2. All applications must be signed by the State Jaycee President

All fees must be paid by check or money order from the chapter submitting the application. (*or check/money order to NC JCI Senate and appropriate credit card information on the application for JCI and JCI USA fees*)

Presentation
